## ARIZONA STATE TAX CREDIT CONTRIBUTION FORM



Arizona law (ARS 43-1089.01) provides that an individual may claim a credit for making contributions or paying fees to a public school for support of qualified activities or programs. The credit is equal to the amount contributed or fees paid. However, a single taxpayer credit cannot exceed \$200. For married taxpayers filing jointly, the credit cannot exceed \$400. Qualified activities or programs include:

- Extracurricular activities – defined as school-sponsored activities that may require enrolled students to pay a fee in order to participate.
- Character education programs (A.R.S. §15-719)
- Standardized testing fees for college credit or readiness, such as SAT, PSAT, ACT, advanced placement and International baccalaureate diploma tests
- Preparation courses and materials for standardized testing
- Career and technical education industry certification assessment
- Cardiopulmonary resuscitation training pursuant to A.R.S. §15-718.01
